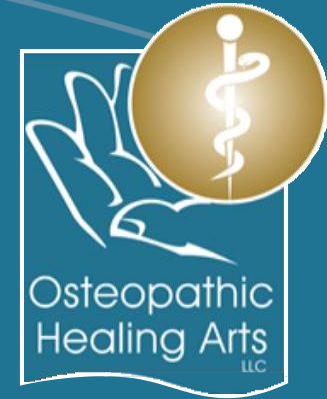

As a patient, you and Dr. Starkman will make decisions about your healthcare, without the impersonal management that inevitably comes from third-party payers. DPC is not a substitute for healthcare insurance, and often works best when coupled with a high deductible, low monthly premium plan coupled with an HSA.
